

PERSONAL DATA OWNER APPLICATION FORM

GENERAL DESCRIPTIONS

This Personal Data Owner Application Form (“Application Form”) is submitted by the data owners (hereinafter referred to as the “Applicant”) to the Personal Data Protection Law No. 6698 before Game Cafe Services Bilişim ve İletişim Hizmetleri Ticaret Limited Şirketi, (“Game Cafe”). It was created for the purpose of being used in applications to exercise their rights regulated by Article 11 of the Law (“KVKK”).

In this context, we would first like to point out that, in accordance with the aforementioned article, you have the following rights regarding yourself as a personal data owner:

- a) Learning whether personal data is processed or not,
- b) Requesting information if personal data has been processed,
- c) Learning the purpose of processing personal data and whether they are used for their intended purpose,
- ç) Knowing the third parties to whom personal data is transferred at home or abroad,
- d) Requesting correction of personal data if they are incomplete or incorrectly processed,
- e) Requesting the deletion or destruction of personal data within the framework of the conditions stipulated in Article 7 of Law No. 6698,
- f) To request that the transactions carried out in accordance with paragraphs (d) and (e) be notified to third parties to whom personal data is transferred,
- g) Objecting to the emergence of a result against the person by analyzing the processed data exclusively through automatic systems,
- ğ) To request compensation for the damage in case of damage due to illegal processing of personal data.

If you have a request from Game Cafe in accordance with Article 11 of the Law, please notify us by filling in the information below and submitting your request.

In this context, applications to be made in writing to Game Cafe can be sent to us by printing this form and using the following methods:

- Through a notary,
- Signed by the applicant with the "secure electronic signature" or mobile signature defined in the Electronic Signature Law No. 5070 and sent to the Company's registered e-mail address or using the e-mail address previously notified to Game Cafe and registered in Game Cafe's system. Your applications submitted to us will be responded to within thirty days from the date your request reaches us, depending on the nature of the request, in accordance with the 2nd paragraph of Article 13 of the KVKK. Our responses will be delivered to you in writing or electronically in accordance with the provision of Article 13 of the relevant KVKK.
